Juror, Joe Amrhein, artist and director of Pierogi Gallery, Brooklyn, NY

JUROR

Axis Gallery is pleased to have Joe Amrhein as juror for the 5th National Juried Exhibition. Joe Amrhein is an artist and founder/director of Pierogi Gallery in Brooklyn, New York. Amrhein was born and raised in California and worked as an artist in San Francisco and Los Angeles before moving to Brooklyn in 1989. He started Pierogi, originally located in his Williamsburg studio, in 1994. In 1999 Pierogi moved to a larger location next door to its original space. In 2006 Amrhein opened a second Pierogi location in Leipzig, Germany which, although originally envisioned as a one year project, operated there for 3 years. In March of this year Amrhein opened The Boiler, a satellite exhibition space to Pierogi's original location nearby in Williamsburg. In this space Pierogi can mount more ambitiously scaled exhibitions as well as performances and other events. Amrhein continues to work as an artist and recently had a one-person exhibition with Dogenhaus Galerie at Volta New York, and a two-person exhibition at the Städtische Galerie Wolfsburg (Wolfsburg, Germany), and was included in "The Carnival Within," a group exhibition in Berlin's Uferhallen, among others. He received an honorary doctorate from Pratt Institute in 2005.

There is a (nonrefundable) \$30 entry fee for up to three submissions, \$5.00 each additional entry, limit 6. Entry by CD only. CD's will not be returned. Make checks payable to **Axis Gallery**.

SALES

Sales are encouraged. The gallery will retain 40% commission on any works sold. Price of work should include commission.

INSURANCE & LIABILITY

Work will be insured at **Axis Gallery** but not in transit. The gallery will not assume responsibility for work improperly framed or poorly packaged for shipping.

SHIPPING

Shipping instructions will be sent to artists whose work has been accepted into the exhibition.

ENTRY DEADLINE

May 26, 2010

ELIGIBILITY & MEDIA

- Open to artists residing in the U.S.
- Contemporary original 2D and 3D work in any media, including paintings, prints, drawings, photography and digital images.
- 2D work should not exceed a framed size of 36" in the longest dimension.
- 3D work limited to 24" in the longest dimension and not more than 60 lbs.
- All work must be original (no reproductions) and produced within the last two years.

CD SUBMISSION REQUIREMENTS

- Up to six works may be submitted as JPEGs on CD.
- Image should be at least 800x800 pixels, no larger than 1500x1500 pixels and saved as JPEGs at the highest quality setting.
- Title digital files with the artist's last name, first initial, and number corresponding to the entry form. ie. Smith_A_1.jpeg
- All other information, title, size, medium, etc. to be mailed with CD on the hard copy entry form.
- CD should be clearly labeled with the artist's name.
