Open to artists residing in the U.S. 2D and 3D work including paintings, prints, drawings, digital images, photo processes, produced within the last two years. (no iris or giclee reproductions). Work should not exceed 36" including frame, 3D work limited to 24" in all directions and not more than 60 lbs.

### JUROR

Axis Gallery is pleased to have **Philip E. Linhares** as juror for the 3rd National Juried Exhibition. Philip E. Linhares is currently Chief Curator of Art at the Oakland Museum of California from 1990 to present. From 1967 to 1977, he was Director of Exhibitions at the San Francisco Art Institute, and from 1978 to 1990, Director of Mills College Art Museum.

### CD SUBMISSION REQUIREMENTS

- Up to six works may be submitted as JPEGS on CD.
- Image should be at least 800x800 pixels, no larger than 1500x1500 pixels and saved as JPEGS at the highest quality setting.
- Name digital files with the artist's last name, first initial, and number corresponding to the entry form. ie. Smith\_A\_1.jpeg
- All other information, title, size, medium, etc. to be mailed with CD on the hard copy entry form.
- CD's should be clearly labeled with the artist's name.
